The 57th Annual Independence Day Festival will be held in Historic St. Marys GA, 8 miles east of I-95. All activities will be held on the waterfront on St. Marys Street and downtown's main street, Osborne Street. To get there, take exit 3 off I-95 east to St. Marys on Georgia Hwy 40 approximately 7 miles to a stoplight at the intersection of Hwy 40 and Dilworth Street. Turn right, follow Dilworth Street (which curves to the left and becomes St. Marys Street) 1.7 miles to a barricade at Bartlett Street for Vendor Check-In. Late Vendors: Vendors arriving after 9am may not enter festival area. We will do our best to provide space outside main the festival area. No power will be available outside main festival area.

CHECK-IN BEGINS AT 6:00AM ONLY AT THE INTERSECTION OF ST. MARYS AND BARTLETT STREETS. BOOTH SPACE NUMBERS WILL BE GIVEN OUT AT CHECK-IN. Booths must be setup and all vehicles out of the exhibit area **NO LATER THAN 9:00AM!** (Parking is available on side streets).

INFORMATION FOR ALL VENDORS - NO SMOKING WITHIN 25' OF VENDOR BOOTHS.

- All Vendors must be gone no later than Midnight
- Vehicles may return to festival area ONLY during 4:30 pm - 5:30 pm and after 10:00 pm
- Vendors not gone by 5:30 pm must remain until after fireworks
- All food vendors must use sand or absorbent materials for oil/grease
- All vendors are responsible for removal of all litter in their booth space
- Set-up is on street surface
- No soliciting, broadcasting, amplified sound, or advertising outside booth; no hawking
- No Loud music from booth without prior approval from Kiwanis
- Ensure cords do not create tripping hazards
- Vendors must furnish their water and ice
- No sale of fireworks or snap`n pops
- No sale of alcoholic beverages
- Festival will take place rain or shine
- **NO PETS ALLOWED in festival area**
- **We do not process applications until fees are paid**

ELECTRICITY

- Vendors requiring electricity must pay for it in advance as set forth in fee schedule; be prepared to furnish extension cords up to 150 feet in the unlikely event outlets are not nearby
- **Only food vendors may use generators**

FOOD VENDORS

- **ALL FOOD VENDORS MUST HAVE A MINIMUM 5LB ABC FIRE EXTINGUISHER!**
- Generators are strongly encouraged. Electrical outlets in the food vendor area are limited.
- **Re: Icy/Frozen Drink vendors:** Two are allowed. First come and paid, first accepted. PayPal invoice will be sent to first applicant, based on date/time of application email with 24 hours to pay. If no PayPal payment is recorded an invoice goes to the next vendor allowing them 24 hours to pay, and so on, in order of application and payment.
